Pursuant to Article 43 of the Environmental Conservation Law and the Lake George Park Commission Prohibition of Aquatic Invasive Species Regulations, 6 NYCRR Subpart 646-9 the Lake George Park Commission (LGPC) and the Launch Owner set forth the following:

1. The Launch Facility Owner (hereinafter Launch Owner) certifies that (she/he/it) is the owner of the launch listed above (hereinafter "launch").

2. The Launch Owner certifies that (she/he/it) is a bonafide homeowners association (hereinafter "HOA") recognized by New York State. HOA bylaws are attached hereto for reference.

6. The Launch Owner certifies that the trailered vessels listed herein launch only into Lake George during a boating season and do not travel to any other waterbody before or after they have first launched into Lake George.

3. Contemporaneous with the signing of this Agreement/Registration, the Launch Owner shall provide the LGPC with a list of all properties and associated land owners legally eligible to

join the homeowners association (form attached). This list shall be attached hereto and incorporated herein. The Launch Owner agrees to update this list and provide copy of such whenever there is a real property transfer within the HOA.

4. Contemporaneous with the signing of this Agreement/Registration, the Launch Owner shall provide the LGPC with a list of all trailered vessels owned by the Launch Owner or current members of the HOA (form attached). This list shall be attached hereto and incorporated herein. The Launch Owner agrees to update this list and provide copy of such to the LGPC as necessary to ensure compliance with the terms herein.

5. No vessels other than those owned by the Launch Owner or a member of the HOA and listed herein may use the launch. Upon sale of vessels listed herein the Launch Owner shall contact the LGPC to update this agreement. Prior to launch of any additional vessels owned by the Launch Owner or HOA members, the Launch Owner shall contact LGPC and execute a new Boat Launch Agreement.

7. As long as the vessels listed herein have last launched into Lake George, their owners may use the launch herein without first undergoing the mandatory inspection process described in 6 NYCRR 646-9.4.

8. In the event that any of the vessels listed herein travel to any other waterbody prior to launching into Lake George, the Launch Owner will not allow such vessel to use the launch herein. Rather, such vessel must travel to one of the LGPC regional inspection stations, and receive a Vehicle Inspection Control Seal prior to launch into the Lake George.

9. The Launch Owner shall secure the launch to prevent trailered vessels from unlawfully using this facility launch. The Launch Owner agrees to secure the launch in the following manner:

11. The Launch Owner's agreement to the terms and conditions of this Launch Agreement/Registration is conditioned upon formal ratification by the HOA membership. This agreement shall be null and void until such time as ratification is obtained and documentation of this is provided to the LGPC.
